Uploading of required documents by the candidates before application deadline

## 09 Online Application Form

- Applications must be submitted online via the website: <https://admissions.vit.ac.in/ugapplications/login>
- Candidates should register with a valid email ID and mobile number, as all correspondence will be communicated through these registered email/mobile number only.
- The application cost is Rs. 1,150 and it is non-refundable.

### Steps to be followed for online application:

- Step 1: Register yourself by clicking on "Sign Up" (New applicant).
- Step 2: Verify your registered email address by using the OTP received from VIT.
- Step 3: Once OTP is validated, a password will be sent to your registered email address. Keep this Email ID and password secure until the admission process is complete.
- Step 4: Fill out the online application form with required information. The list of Boards along with respective code is listed out in the Annexure. The Board code of study in the qualifying examination should be mentioned accurately. In case of any discrepancy in the board filling on the application form and submission of relevant document at the time of admission will lead to cancellation of admission.
- Step 5: Pay the non-refundable application fee of Rs.1150 using Net banking, Debit card, Credit card or Paytm.
- Step 6: Upload Age proof certificate, 10th mark sheet, 12th hall ticket and 12th mark sheet.

**Applicants need to upload the following mentioned documents on the application portal, subject to their availability within the specified timeframe.**

- Copy of Age proof certificate (Birth Certificate/ Passport Copy)\*
- Copy of X Mark statement\*
- Copy of XII Hall Ticket\*
- Copy of XII Mark statement (for all attempts)\*
- Copy of Community Certificate (For SC/ST Applicants)
- Copy of Nativity Certificate (For Applicants hailing from North Eastern States and Jammu & Kashmir/ Ladakh)

Note: Fields marked with asterisk (\*) are mandatory

## 10 Eligibility

### For First 2 Years (At VIT BS):

- Minimum 80% in 10th and 12th grades (Mathematics is mandatory in 12th).
- Must clear Personal Interview.

### For Next 2 Years (At Binghamton University SoM):

- Cumulative GPA of 8/10 at VIT.
- Proof of English Proficiency as per International Standards.
- Submission of official transcripts and admission application.

## 11 Declaration of Results

- Rank List announcement based on the 10th/12th marks.
- Shortlisted candidates will be called for personal interview.

## 12 Selection Criteria

- Admission will be based on the 10th/12th board marks.
- Seat allotment is based on the candidate's rank and seat availability.
- Information regarding seat allotment, instructions for admission fee payment, and downloading the allotment letter will be communicated to the candidates through the counselling portal.
- Provisional admission is subject to cancellation at any point of time if the candidate fails to fulfil the eligibility requirements.
- Qualifying and being called for counselling do not guarantee admission. Admission is based on the candidate's rank and seat availability.

## 13 Tuition Fees

Years 1 & 2 (India): ₹2,00,000 per year

Years 3 & 4 (Abroad): \$ 15,225 per semester

Additional charges apply for the hostel, travel, and other facilities. Scholarships are available based on academic performance (for candidates scoring above 90% in the 12th Board exam)

In case of submission of any fraudulent, incompetent certificate by the applicant will lead to legal action and the admission accorded will be duly cancelled and no refund will be initiated.
- The qualifying examination mark statement submitted by the candidate will be verified from the respective board.

## 15 Rules for Students Continuing at VIT after Two Years

Students opting to continue at VIT after two years instead of transferring must:

- Complete the remaining two years at VIT under the same curriculum.
- Maintain the minimum required CGPA for progression.
- Follow the academic and disciplinary regulations set by the University.
- Internship and placement opportunities will be provided by VIT's career services.





## 16 Withdrawal Procedure

- Candidates can request withdrawal through online.
- The necessary form for withdrawal/clearances must be obtained to facilitate the withdrawal process.
- The withdrawal application date is considered as the date of submitting the clearance form.
- Refund will be processed through account transfer to the bank account mentioned in the withdrawal request. Accurate bank account details must be provided.

- **Q4. What is the visa process for students transferring abroad?**  
The partner university assists with the visa application, and students must meet all legal requirements.
- **Q5. What career opportunities are available after this program?**  
Due to the importance of advanced quantitative skills required across sectors, a bachelor's degree in Financial Analytics will pave the way to get a job as a financial analyst that's highly demanding and lucrative.
