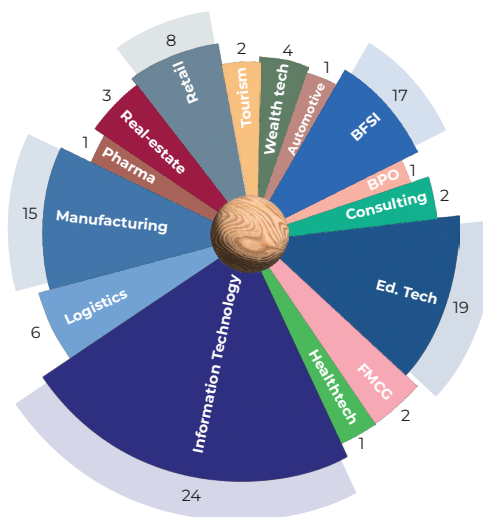

Eligibility Criteria

Students with outstanding aptitude scores or percentiles are eligible for tuition fee waivers:

Minimum Academic Requirement:

A Minimum of 60% marks of First Class in any undergraduate or integrated degree from a recognized university or institution.

Degree Duration:

A bachelor's degree with a minimum duration of three years after completing higher secondary education (10+2+3, 4 or 5) or equivalent.

Final Year Students:

Candidates appearing for their final year examination in 2025 with results to be published on or before 14th August 2025 are also eligible to apply.

Selections Process:

Admission is based on valid scores in CAT / XAT / MAT / GMAT / CMAT / ATMA / NMAT

Relaxation for specific categories:

Eligibility criteria are relaxed by 10% in UG degree for:
Applicants belonging to SC/ST categories.
Applicants hailing from Jammu & Kashmir, Ladakh and North-Eastern States (Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim).



Scholarships

Students with outstanding aptitude scores or percentiles are eligible for tuition fee waivers:

CAT / XAT / GMAT:

95 percentile and above: Full tuition fee waiver

90 percentile and above: 50% tuition fee waiver

MAT:

791-800 score: Full tuition fee waiver

760-790 score: 50% tuition fee waiver

NMAT:

346-360 score: Full tuition fee waiver

325-345 score: 50% tuition fee waiver
