1. Introduction: ABOUT VIT

4.1. Nationality

◆ The applicants for admission should be a **Resident Indian National** and should have studied in **regular**, **full time and formal education** schools located in India in the preceding two years. (10 +2 year)

	(i) VIT-Vellore and VIT-Chennai Campus:
1. General Eligibility	A pass in Higher Secondary Examination conducted by the State / Central Board of Secondary Education or its equivalent examination with 70% aggregate in Physics, Chemistry and Mathematics (PCM). (ii) VIT – AP and VIT Bhopal Campus:
	A pass in Higher Secondary Examination conducted by the State / Central Board of Secondary Education or its equivalent examination with 65% aggregate in Physics, Chemistry and Mathematics (PCM).
2.	(i) VIT-Vellore and VIT-Chennai Campus:
For SC/ST, Jammu & Kashmir, Ladakh and North Eastern states:	The Qualifying Marks is relaxed by 10% i.e. 60% in PCM for applicants belong to SC/ST and applicants hailing from Jammu & Kashmir, Ladakh and the North Eastern states of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim & Tripura.
	(ii) VIT – AP and VIT Bhopal Campus:
	The Qualifying Marks is relaxed by 10% i.e. 55% in PCM for applicants belong to SC/ST and applicants hailing from Jammu & Kashmir, Ladakh and the North Eastern states of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim & Tripura.
3. Age Limit:	Candidates whose date of birth falls on or after 01.07.2004 are eligible to apply
4. Important notes:	Candidates who have studied in Regular, Full time and Formal Education are alone eligible to apply. Applicants belonging to SC/ST category should submit community certificate. Applicants hailing from Jammu & Kashmir, Ladakh and the North Eastern states of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura. They should submit Nativity Certificate.

6. Admission procedure

- Applications are processed in the order of merit, based on the aggregate of marks (rounded to 2 decimal points) secured in Physics, Chemistry and Mathematics in the +2 / Higher Secondary & Intermediate Examination.
- In case the Normalization Marks are same, the order of merit will be decided based on the best scores in Mathematics, Physics, Chemistry sequentially, also based on total obtained scores in all subjects.
- ◆ Short listed applicants list will be published on **04.06.2024 (Tentative) after that,** applicants can give their campus and program preferences on **04.06.2024 to 05.06.2024** (i.e., applicants can give "n" number of choices)
- ◆ Seat will be allotted based on Rank, Preference of Campus, Programme (Subject to availability).
- Once Allotment is done on 07.06.2024 (Campus, Programmes), it cannot be changed under any circumstances.
- ◆ Selected applicants will receive their Provisional Admission Letter to pay their Tuition Fees through online mode on or before 18.06.2024. (Tuesday).
- The Orientation & Commencement of classes To be Announced; details will be sent through Email.

8. General Discipline:

- All applicants admitted to the Institute shall maintain good conduct, pay the requisite tuition fees
 and other charges by the due dates, attend their classes regularly and abide by the rules and regulations of the Institute.
- If at any point of time, if the conduct and character of an applicant is not satisfactory or is of suspicious nature, the Management reserves the right, without assigning any reason, to make him /her vacate the hostel or expel him/her from the Institute.

8.1. Measures for prevention of ragging at the institution level:

- Ragging is totally prohibited in the institution and anyone found guilty of ragging and / or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with the regulations as well as under the provisions of any penal law for the time being in force.
