S.No	Suggestions of IQAC meeting held on 08-10-2015	Action Taken
1	Quality parameters need to be defined quantitatively and the benchmarks need to be set	The Quality Parameters as defined by NAAC was adopted in internal Academic Audit
2	Analysis on the quality parameters to be done at the school level	The academic audit has been conducted school wise
3	Learning basic concepts by the students need to be strengthened	Introduction of more project based courses in revised curriculum
4	More industry based workshops need to be organised and the students need to be involved in that	Schools and research centres are encouraged to invite experts from industries to conduct workshops/seminars/guest lectures.  In the annual performance incentive points are awarded for faculty who organised industry guest lectures.
5	The faculty members could visit the industry for a period of 2 – 3 days along with the student, during the project period	It was forwarded to the school deans for consideration.  The guides visited industry during the project period and review the work progress of the students along with the industry supervisor.

1	The research publication analysis should include not only the research output of the schools in general, but should involve identification of faculty categories as teaching and research-oriented	Faculty members with research inclination have been identified and attached with research centres
2	The projects proposals to be reviewed by an internal committee before it is being sent for extramural funding.	Expert committee constituted by Office of Sponsored Research reviews the new proposals and gives suggestions for improvement and recommends for further processing
3	The manuscripts submitted could also pass through a technical review committee if the quality needs to be improved. Acommittee could also be formed to correct the grammatical errors and other non-technical mistakes.	Workshops on writing quality research papers have been organised through Academic Staff College for faculty and research scholars.  Turnitin software is being used to check plagiarism.
4	The IQAC should identify specified areas for focusing on research activities.	Thrust areas for focused Research have been identified collectively and communicated to the Vice Chancellor for further action
5	The faculty members should also try to establish as many external contacts as possible. This will not only aid in good technical support but also will set an image for the University	The faculty members are sponsored to attend national and international conferences, workshops and visit reputed universities in India and abroad
6	Mock interviews could be conducted for students. This will enable students to face the challenges during their placement interviews or during admission to higher education. In the revised performance evaluation form annual targets in academic, research and administrative domains have been set.
