



ELIGIBILITY CRITERIA

- A minimum of 60% mark or first class is required in any Under Graduate or Integrated degree from a recognised University or Institution.
- A Bachelor's degree should be of a minimum of three years duration after completion of higher secondary education (10+2+3, +4 or +5) or equivalent.
- The candidates appearing for final year examination in 2024, whose results will be published before 15th August 2024, are also eligible to apply.
- · Selection based on best score in CAT / XAT / MAT / NMAT / GMAT / CMAT / ATMA.
- The qualification criteria is relaxed by 10% in UG degree for applicants belonging to SC/ST and applicants hailing from Jammu & Kashmir, Ladakh and the North Eastern states of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura.

SCHOLARSHIPS

Students who possess a valid aptitude score or percentile are eligible to get the fee waiver mentioned below.

- CAT / XAT / GMAT Score of 95 percentile and above are eligible for full tuition fee waiver.
- CAT / XAT / GMAT Score of 90 percentile and above are eligible for 50% tuition fee waiver.
- MAT score of 791 to 800 are eligible for full tuition fee waiver.
- MAT score of 760 to 790 are eligible for 50% tuition fee waiver.
- NMAT score of 346 to 360 are eligible for full tuition fee waiver.
- NMAT score of 325 to 345 are eligible for 50% tuition fee waiver.
