### **Subject: Awareness Regarding Fraudulent Agents Claiming Direct Admission to VIT**

This is to inform all prospective students and parents that certain agents, individuals, and organizations are falsely claiming to offer **direct admission to Vellore Institute of Technology (VIT)** group of institute through unofficial means.

Any communication received through phone calls, emails, SMS, WhatsApp, or social media platforms promising direct admission or seeking payment is **fraudulent. Please note that police complaints and FIR have been lodged against persons indulging in such malpractices.**

Students and parents are strongly advised:

- Not to believe such false claims
- Not to share personal or academic details other than link through <https://vit.ac.in>
- Not to make any payments to unauthorized individuals or agencies

Vellore Institute of Technology (VIT) adheres to the **highest standards of admissions integrity**, and all admissions to VIT are conducted **strictly on the basis of merit** through established and transparent procedures. VIT **will initiate required criminal and legal actions against any unscrupulous individuals/entities/agencies trying to interfere in the fair and transparent conduct of Entrance Examination.**

Candidates are **strongly cautioned** against falling victim to agents or misleading communications offering admissions through unauthorized means. Any individual or entity found engaging in such fraudulent activities will be dealt with **strictly**, including the initiation of **appropriate criminal and legal proceedings** as per applicable laws.

It is further clarified that VIT shall **not be responsible or liable**, under any circumstances, for any loss, damage, or claims arising from actions taken based on **unauthorized, fraudulent, or misleading emails, phone calls, messages, or admission offers** not officially issued by the Institute.

All admissions to VIT are conducted **strictly through official notifications and procedures** published on the institute's official website.
