About the Program:

The Integrated M.Tech. program at VIT (Vellore Institute of Technology) is a distinguished 5-year course tailored for students who have completed their 10+2 (or equivalent) with a strong foundation in science, particularly in Physics, Chemistry, and Mathematics. Admission is based on 10+2 marks, with no entrance exam required.

This program emphasizes advanced technical skills, research, and practical exposure, equipping students for careers in fields such as software development, data science, and research. It offers outstanding opportunities for professional growth and innovation, making it a highly valuable choice for aspiring technology professionals.

4 Eligibility and Fees:

4.1. Nationality

- ◆ The applicants for admission should be a **Resident Indian National** and should have studied in **regular, full time and formal education** schools located in India in the preceding two years. (10 +2 year)

6. Admission procedure

- ◆ Applications are processed in the order of merit, based on the aggregate of marks (rounded to 2 decimal points) secured in Physics, Chemistry and Mathematics in the +2 / Higher Secondary & Intermediate Examination.
- ◆ In case the Normalization Marks are same, the order of merit will be decided based on the best scores in Mathematics, Physics, Chemistry sequentially, also based on total obtained scores in all subjects .
- ◆ Short listed applicants list will be published on **04.06.2025 (Tentative) after that**, applicants can give their campus and program preferences on **04.06.2025 to 06.06.2025** (i.e., applicants can give “n” number of choices)
- ◆ Seat will be allotted based on Rank, Preference of Campus, Programme **(Subject to availability)**.
- ◆ Once Allotment is done on **10.06.2025** (Campus, Programme), it cannot be changed under any circumstances.
- ◆ Selected applicants will receive their Provisional Admission Letter to pay their Tuition Fees through online mode on or before **20.06.2025. (Friday)**.
- ◆ The Orientation & Commencement of classes **To be Announced** ; details will be sent through E-mail.

- **If any information or the provided certificate is found false at any stage of the Admission process, the admission will be cancelled and suitable legal action will be taken.**

- In due of original TC submitted, a TC from VIT will be issued on completion of the course. The candidates should produce statement of final year marks and provisional degree certificate before **15th August, 2025** failing which admission will be cancelled with the forfeit of admission fee.

9. General Discipline:

- ◆ All applicants admitted to the Institute shall maintain good conduct, pay the requisite tuition fees and other charges by the due dates, attend their classes regularly and abide by the rules and regulations of the Institute.
- ◆ If at any point of time, if the conduct and character of an applicant is not satisfactory or is of suspicious nature, the Management reserves the right, without assigning any reason, to make him /her vacate the hostel or expel him/her from the Institute.

9.1. Measures for prevention of ragging at the institution level:

- ◆ Ragging is totally prohibited in the institution and anyone found guilty of ragging and / or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with the regulations as well as under the provisions of any penal law for the time being in force.
- ◆ Ragging Juniors in any form is forbidden. If anyone is found ragging his/her juniors, he/she can be rusticated from the Institute.
- ◆ It is mandatory that Applicants and parents who are attending interview/joining admission in VIT has to sign an undertaking in Rs.200/- non-judicial stamp paper as per the information given in Annexure-I & II (as per UGC Regulations-2009, www.ugc.ac.in).

Separate hostel accommodation is available for boys and girls.

- ◆ Hostel accommodation will be provided only to those Applicants whose residence is beyond 100kms radius from the Institute.

11. Admission Cancellation Process / Refund of Fees:

11.1. Academic Cancellation:

- ◆ With the Proctor approval Student can apply Online Application for Cancellation of Admission (cancellation link will be provided on VIT website Home page.

- ◆ Submit original Provisional Admission Letter
- ◆ TC will be given only if original Migration / Transfer / College Leaving Certificate submitted already.

AICTE - Post Graduate (PG) Scholarship for Integrated M.Tech. Programmes

On-line proposals are invited from AICTE approved Institutions for disbursement of Post Graduate Scholarship to the Students of **Integrated M.Tech. Programmes** i. e. **from the 9th semester onwards**, only for one year in final year.

- 1. Objectives of the Scheme:** AICTE in order to ensure development of technical education in India awards Post Graduate Scholarship of Rs. 12,400/- per month to full-time GATE/CEED qualified students admitted to AICTE approved post graduate programs in AICTE approved Institutions/ University Departments as per AICTE approved intake.
- 2. Amount of Scholarship:** The Scholarship under the scheme is Rs. 12,400/- per month per student.
- 3. Duration:**
 - a) The Scholarship is tenable for 24 months or for the duration of the course i.e. from the date of commencement of classes till the date of completion of the classes whichever is lower and is not extendable under any circumstances.
 - b) Students of final years of dual degree integrated programmes would also be entitled to PG Scholarship from the 9th semester onwards i.e. only for one year in final year.
- 4. Eligibility for Scholarship:** Post Graduate Scholarship is entitled only to those students:
 - (i) Having a valid GATE/CEED score at the time of admission.
 - (ii) Must be admitted as a full-time scholar.
 - (iii) **Students of final years of dual degree integrated programmes would also be entitled to PG Scholarship from the 9th semester onwards i.e. only for one year in final year.**
 - (iv) Admitted in AICTE approved Institutions/University Departments & AICTE approved programs viz. Master of Engineering, Master of Technology and Master of Design.
 - (v) Number of PG Scholarship is limited to the AICTE approved intake in the programme in that year. However in addition to the approved intake, AICTE will provide PG scholarship to the additional 10% candidates over and above the approved intake of that course from EWS category, if the university/ institute has admitted students from Economically Weaker Sections (EWSs) as per MHRD OM F.No.12-4/2019-U1 dated 17th January 2019.
- 5. Other Entitlements:** Maximum of one month (30 days) in an academic year : Candidates are eligible for maternity/ Paternity leave as per Govt. of India norms issued from time to time at full rates of scholarship etc. once during the tenure of their award. However maximum duration of scholarship will not be extended in any circumstances.
