#### **1. ABOUT VIT**



#### **4. NATIONALITY**

The applicants for admission must be **Resident Indian National** and must have pursued their graduation in **regular, full time and formal education** colleges located in India and abroad.

#### Note:

- The qualification criteria is relaxed by 10% i.e. 50% in UG degree for applicants belonging to SC/ST category and applicants hailing from Jammu & Kashmir, Ladakh and the North-eastern States of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura.
- Applicants belonging to SC/ST category must fill in the proformance given in Appendix-II and have it attested by acompetent authority (The list of authorities empowered for the same is given in Appendix-II).
- Applicants hailing from Jammu & Kashmir, Ladakh and the North-eastern States of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura should fill in the Nativity Certificate given in Appendix-I.
- Applicants from Open University / Correspondence mode are not eligible.

#### 6. ADMISSION PROCEDURE

- Selection is based on UG degree marks secured up to Pre-Final Year / Semester for (Result awaited candidate) or Final Year / Semester for (Degree Completed candidate).
- Tentative date for preference of campus and programme and allotment of seats will be on **12 & 13 June 2025**.
- Allotment of seat for a programme and campus once made is final and cannot be changed under any circumstances.
- If the applicant fails to qualify in the prescribed qualifying examination, the provisional admission accorded will stand cancelled and the fee remitted will be forfeited.
