About VIT Master's Entrance Examination (VITMEE) for M.Sc. Programmes:

The M.Sc. (2 Years) program at Vellore Institute of Technology is available in various disciplines, including Artificial Intelligence and Machine Learning (AI & ML) and Data Science. Admission is based on the rank obtained in the VITMEE 2026.

Vellore Institute of Technology Engineering Entrance Examination (VITMEE) is conducted for admission to postgraduate engineering programmes in VIT group of Institutions. VITMEE will be conducted on 28th April 2026 and 03rd May 2026 at designated centres across India. The duration of the examination will be 2 hours. Candidates can appear only once for VITMEE-2026. All the questions will be Multiple Choice Questions and one mark for the right answer and zero for the wrong answer. There is no negative marking for wrong answers. Those who score '0' in total will be declared as 'Not qualified' and will not be eligible to participate in the counselling process. The Computer-Based Test (CBT) objective question Paper consists of 100 questions with a maximum of 100 marks. Of these, 80 will be from the chosen technical subject and 20 will be from English communication. The question paper will be in English only.

4. NATIONALITY:

- The applicant for admission should be a Resident Indian National and should have graduated from institutions located in India.
- Foreign and NRI/ PIO candidates must apply separately. For further details, please visit the
 International Relations tab in VIT website.

Note:

- ◆ The qualification criteria is relaxed by 10% i.e. 50% in UG degree for applicants belonging to SC/ST category and applicants hailing from Jammu & Kashmir, Ladakh and the North-eastern States of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura.
- Applicants belonging to SC/ST category must fill in the performance given in Appendix-II and have it attested by a competent authority (The list of authorities empowered for the same is given in Appendix-II).
- Applicants hailing from Jammu & Kashmir, Ladakh and the North-eastern States of Arunachal Pradesh, Assam, Mani pur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura should fill in the Nativity Certificate given in Appendix-I.
- ◆ Applicants from Open University / Correspondence mode are not eligible.

5. Eligibility Criteria:

- The following are the basic prerequisites for candidates:
- A full-time degree from any recognized University/Institute with a minimum aggregate of 60% of marks or First class in qualifying for the M.Sc. degree programme is required, as well as in class 10th and 12th.
- Candidates appearing for their final degree exam / final semester exam in the current year are also eligible to apply.
- Completion of final Semester/year exams before the selection at VIT.

Documents:

- UG Semester wise or Consolidated mark sheets, X and XII Std. Mark Statements
- Statement of final year marks and Provisional degree certificate
- ◆ The above documents should be submitted before 15 August 2026, failing which admission will be cancelled with the forfeit of admission fee.

Placement Requirements:

Information Technology Sector Placement at VIT have stipulated a minimum of 60% Marks for candidates in their undergraduate programmes and in class X and XII. An academic gap of maximum two years is permitted.

6. ADMISSION PROCEDURE:

- The applicants should apply online in the respective link provided in the website (www.vit.ac.in) by paying a non-refundable application fee of Rs.1200/- (rupees of the thousand two hundred only, including GST).
- Applicants should register for VITMEE, a Computer Based Objective test at indicated test centres.
- The list of short-listed candidates will be published in the website or personal SMS will be sent to the registered mobile number for online counselling.
- Short-listed Candidates will be asked to choose the preference of campus. Selected candidates will have to pay the full fees within of payment through online mode.
- Candidates who fail to pay the full fees within the deadline, will not be considered for admission.

Pattern of the Question Paper:

- The Computer-Based Test (CBT) objective question Paper consists of 100 questions with a maximum of 100 marks.
- Of these, 80 will be from the chosen technical subject and 20 will be from English communication. There are no negative marks for wrong answers.

8. ADMIT CARD for VITMEE-2026:

- Admit cards can be downloaded from <u>www.vit.ac.in.</u> Admit Card will not be faxed or sent by post or e-mail personally.
- The candidates must not mutilate the Admit card or alter any entry made therein.
- The Admit card is not transferable to any other person. Impersonation is a legally punishable offence.
- The Admit card will contain your name, registration number, photograph, Signature, your postal address, slot, and date of examination and also the address of your test centre, test schedule and set of instructions for the test.
- The candidate should carefully examine the Admit card once received. Any discrepancy should be immediately brought to the notice of the Director (PG Admissions). mscadmission@vit.ac.in or +91-416-220 2188/2050/2060/2055.
- Applicants will not be permitted to write the test without a valid admit card. The Admit Card should be presented to the invigilators at the test centre for verification.
- The candidates must sign the attendance sheet at the appropriate places at the test centre. The finger print of the candidate writing the examination will be recorded and later verified at the time of counselling.
- The Admit Card should be preserved and produced for verification at the time of counselling / admission.
- Candidates are not eligible for admission in case the applicant violates any instruction or involves unfair means in the examination hall.

9. Online Counselling:

Candidates will be short-listed for online counselling on the basis of their performance in the VIT Master's Entrance Examination (VITMEE) Rank. Short-listed candidates should pay the full tuition fees.

- Candidate will not be permitted to enter into examination hall after 02.15 pm
- Candidate will not be permitted to leave the exam hall until 04.30 pm. even if the exam were completed.
