



The list of Higher Educational Institutions (HEIs) entitled to start full-fledged Online Programmes without prior approval of the UGC, as per provisions stipulated under Regulation 3(B)(a) of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments from academic year 2023-24, academic session beginning July-August, 2023 and onwards.

- (I) As mandated by the Regulations, online applications were submitted by the Entitled HEIs willing to offer programmes under online mode. Further, each HEI submitted affidavit for ensuring compliance to all the provisions of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments and also deposited prescribed fee as notified by the Commission.
- (II) The duly certified information submitted by the HEI, was to ascertain conformity to the following **four provisions only**:
 - 1. Entitlement eligibility criteria of the HEI.
 - 2. Permissibility of proposed programmes to be offered under online mode.
 - 3. Adherence to UGC Notification of Specification of Degrees, 2014 and its amendments.
 - 4. Prior approval of Regulatory Authority, wherever applicable.
- (III) **Programmes under the ambit of Regulatory Authorities have been considered on the basis of communication/recommendations received from respective Regulatory Authority. The HEIs strictly shall abide by the conditions such as number of seats, recognition period, etc. mentioned in the relevant Regulatory Authority letter.**
- (IV) **The Regulations also mandate that the programme-wise Entitled HEIs shall not offer online programmes under any franchise arrangement and shall have complete ownership of these programmes.**
- (V) The HEIs are entitled to offer Online programmes, till they are complying NAAC or NIRF ranking requirements as per Regulation 3(B)(a) of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments and on non-compliance, **they shall discontinue the programmes and accordingly, inform the same to the UGC.** The learners already enrolled in the current entitled programmes shall be allowed to complete the programmes in the laid down manner as per the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments.
- (VI) The List of entitled HEIs which have submitted the affidavit to ensure compliance to University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments and have been found complying with above mentioned provisions (as per (II) above), for academic year 2023-24, session beginning from July-August, 2023 and onwards is appended herewith.
- (VII) Higher Education Institution shall write 'UGC entitled as per University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments' instead of 'UGC recognized' at all places.

- (VIII) The Higher Educational Institution shall scrupulously abide by all the terms and conditions as stipulated under Parts III, IV and V of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including any amendments thereto) and shall take steps as stipulated under Annexure-I to VIII & Annexure-X of the said Regulations.
- (IX) Commission in its 571st meeting held on 25th July, 2023 has decided that last date of admission and last date for uploading of student admission details on the UGC-DEB web portal for offering ODL and Online programmes for academic session July-August, 2023 will be as under:

- ***Last Date for Admission: 30th September 2023.***
- ***Last Date for Submission of Student Data on the Portal: 15th October 2023.***

All Entitled HEIs entitled to offer programmes through online mode shall comply with the above decision of the Commission, failing which, UGC shall take punitive action as per Regulation 7 (3) of UGC (ODL Programmes and Online Programmes) Regulations, 2020 and its amendments.

- (X) The Higher Educational Institutions have submitted an affidavit to the effect that in case any information, documentary evidence submitted/produced by the Higher Educational Institution is found to be false or wrong at a later stage or in case there is any violation of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments by the HEI, the Higher Educational Institution shall be solely liable and responsible for any such contravention/violation and for any consequences thereof (including career consequences of Learner) In such events, the HEI may also be subject to the consequences stipulated under Regulation 7 of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including any amendments thereto).

- When can I expect confirmation of admission?
 - Confirmation of admission occurs after document verification and payment of the first instalment fee.
- I am a fresher. Am I eligible to apply?

- There is no minimum work-experience criteria. If you qualify the eligibility criteria you are eligible.
- Are online education programs considered equivalent to regular programs?
 - All online programs offered by recognized HEIs are deemed equivalent to regular programs according to the UGC ODL & Online regulation, 2020.
- What is the admission process like?
 - The candidate can visit the **programmes.vitoline.in** website, click on "Create Account," then select Relevant Degree. You will be guided through the application process, and after providing basic data, and upload the required documents and you can click "Submit application & Pay Application Fee". VIT Online will communicate with you if you are found eligible, and you can then proceed to pay the tuition.
- Do you retain original certificates?
 - No, we do not keep original certificates.
- Can applications and certificates be submitted online?
 - Yes, all applications and certificates are accepted online only.
- Is there an entrance examination for the VIT Online Degree program?
 - No, there is no entrance exam for joining in the VIT Online Degree programme.
- Why might my application form be rejected?
 - If your application form is incorrectly filled or incomplete, it may be rejected.
- Do online degrees have an expiration date?
 - No, the online degree you receive from VIT Online remains valid for a lifetime.
- Can international students enroll in online degree programs?
 - Yes, they can.
- Can a student simultaneously pursue two degree programs?
 - According to the University Grants Commission (UGC), you can pursue both an on-campus degree and an online degree at the same time.
- Will participants get alumni status and benefits from VIT?
 - Yes, participants who complete the degree will get alumni status and benefits.

Academics

- How will the participants be evaluated?
 - Participants will be evaluated through a combination of internal assessment and an end-term examination, with a 30% weightage given to the internal assessment and a 70% weightage assigned to the end term examination.
- How long does it take for results to be published?
 - Results are typically published at least two months after the last day of examinations.
- Do you follow a non-semester or semester pattern for your programs?
 - Exams are conducted only in a semester pattern, as per UGC's directive.
- What is a proctored examination, and what are the requirements for appearing in online exams?
 - Online exams are conducted with remote students, and online proctoring software is used to maintain exam integrity. It provides automated, standardized, and straightforward supervision.
- Are assignments mandatory?
 - Yes, they are part of continuous assessment.
- Is it required to attend live online sessions?

- Yes, a minimum participation of 75% in all activities is necessary.
- Do participants need to do internship after 1st year? Is it mandatory and carry weightage for grading?
 - No, offline degrees has internship to give corporate exposure to students. Since, this degree is designed for current working professionals, hence internship does not provide any value add, hence not necessary.
- Are the courses completely web-based, and can we access downloadable learning materials?
 - Yes, all aspects, from application to certification, are conducted online. You can access self-learning materials through your Learning Management System, and some of the material can be downloaded.
- How do I retrieve my course materials?
 - Enrolled students can access their learning material through LMS
- Is it necessary to buy textbooks or software?
 - All the necessary materials are provided through LMS. If students wish to procure books for their additional reading, they can at their own expense.
- How many compulsory live sessions are there per course?
 - There is one live session per week.
- How can I engage with my fellow students?
 - You can use the discussion forum to connect with your course coordinator and peers.
- Is it possible to contact faculty members outside of weekend live classes?
 - Yes, you can submit your queries through the learning portal, and the faculty/Academic mentors will respond within 48 hours.
- What is the maximum duration to complete a degree program?
 - For degree programs the maximum duration for completion shall be double the minimum duration of the respective program.

Details of proctored examination

VIT uses a Proctored Assessment platform that supports a variety of different examination question types and responses. It also provides automated remote proctoring services, including recording candidates' movements and background noise. The system monitors deviation based on multiple parameters like screen, microphone, webcam and browser activities and ensures that examinations are conducted securely.

Refund Policy

The refund for withdrawal of admissions will be made to students as per the statutory/ regulatory body's guidelines. The recommended refund schedule is given in the below table-1

The student opting to withdraw from the programme in which he/she is enrolled must submit a written application clearly disclosing the reasons for the withdrawal. Such requests may be admitted on merit after due consideration. Once VIT University approves the refund, the refund amount will be credited to the bank account as provided by the participant.
